1. Once this form and the associated fees/dues have been submitted and accepted by PMI's Dockmaster, this Membership shall be in force from March 1, 2018 until February 28, 2019. Page 2 includes dues/dockage/storage fee information.
2. Club/Family membership applies to "immediate family" (spouse, significant other and dependents under age 25 residing at the same residence). Senior membership applies to couple age 62+ as of 1/1/2018. Single membership applies only to individuals. Frequent guests should be encouraged to become members to support PMI.
3. All guests at PMI must be accompanied by the hosting member at all times. Members hosting 6 or more guests at a time are required to apply for a party permit in advance and pay a \$2.50 per guest fee. Guests are not permitted to launch boats or personal watercraft. There are no guest fees during PMI sponsored social functions. Please register guests with the member on duty.
4. Members and their guests shall exercise reasonable care and common sense while using PMI facilities. Report any malfunctions of PMI equipment to a PMI Board Member. Please leave things cleaner than you found them.
5. PMI grounds and beach are private property and are not open to the public. There is NO LIFEGUARD at PMI. Your children are your responsibility and must be accompanied by a responsible ADULT AT ALL TIMES while in the beach area.

K. USE OF PREMISES

as approved by membership 4/30/2016

- 1. Parents are responsible for the safety and behavior of their children. There is no lifeguard.**
- 2. Campsites may be used by club members and accompanied guests only.**
- 3. No one under 18 years of age may Camp without parental supervision.**
- 4. Unoccupied tents or camp trailers cannot be left on Club property for more than one day.**
- 5. Motorized vehicles are not allowed in the tent camping area except to load or unload equipment**
- 6. The use of Club electrical outlets to service campers and boats is not permitted, exception: medical devices.**
- 7. All members must have their dogs leashed, attended, and under control at all times. Dogs are to be kept off the beach during busy times. Messes that the dog makes must be cleaned up and disposed of in the dumpster. The hill area east of the men's room is the dog walk area (the "clean up mess" rule also applies in this area). No pets are permitted at scheduled Social Events.**
- 8. Please monitor your noise generation in consideration of others particularly after dark when people are retiring for the night.**
- 9. Please use discretion when parking your vehicle. Do not block another member from being able to get their boat or vehicle in or out.**
- 10. Members are responsible for cleaning up after themselves, their children, pets and guests. Please use the containers provided and empty them into the dumpster when full and/or at the end of the day.**
- 11. Boats may not be left on the beach for more than 24 hours if you are not on the premises. Boats left on the beach should not hinder beach access. All boats must be stowed or moved high up to the edge of the grass on Fridays to accommodate the weekly beach raking.**
- 12. Any member or guest not abiding by the by-laws set forth will be given a warning and/or asked to leave the premises**
